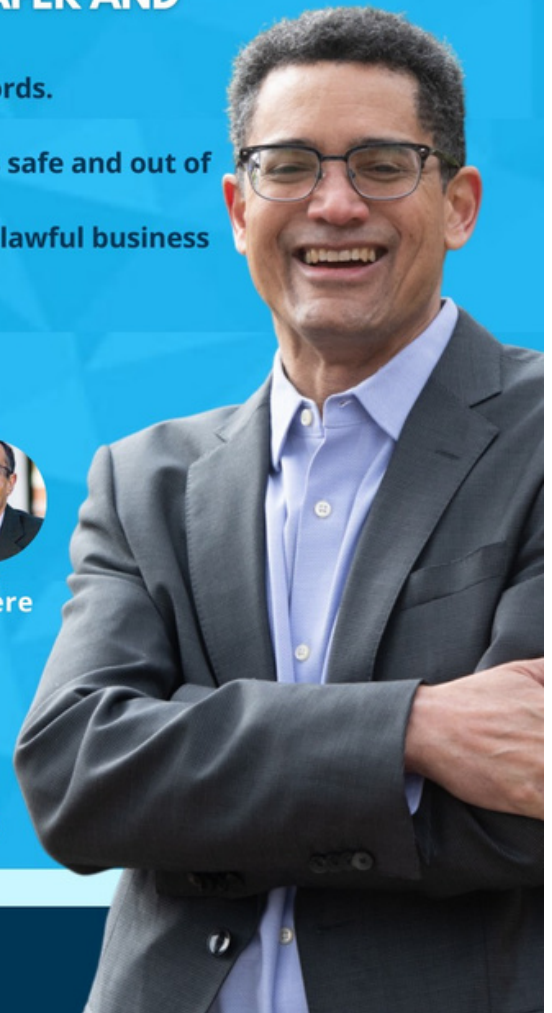

Delia Gonçalves joined the WUSA9 team in June 2010. Delia got her first break in the business right here in Washington at the U.S. Senate Radio-TV Gallery and at NBC Network News. She then left D.C. to pursue her on-camera reporting endeavors, which took her back to her native New England.

Delia spent five years crisscrossing the region, working at several stations in Massachusetts and Rhode Island. During that time, she had the privilege of covering a number of national stories, including the Station Nightclub fire in Rhode Island that claimed 100 lives and the historic vote on gay marriage in Boston – the first vote of its kind in the country.

Before returning to the nation's capital, Delia spent four years in Baltimore where she was named Baltimore's Best Reporter in 2009. Among her most memorable stories in Charm City, Delia's profile of a woman and her daughter living in a home with no electricity or running water got them in a safe shelter. Her reporting on the homeless in DC has helped people get off the streets and reunite families. Delia is passionate about reporting the facts, challenging the status quo, and telling compelling stories at the heart of our community.

Delia is a first-generation Cape Verdean-American born in New Bedford, Massachusetts of immigrant parents who taught her the invaluable lessons of faith, hard work, and perseverance.

She now lives in D.C. with her husband and three daughters.

Markus Batchelor is a native Washingtonian, advocate and activist who formerly served as the Ward 8 Representative, Vice President and the youngest-ever elected member of the DC State Board of Education. He is currently the Deputy Director of Leadership Programs at People for the American Way. He is also the Chair of the Membership and Voter Outreach committee for the Ward 8 Democrats.

Markus spent his career in government, non-profit and as an elected leader working to close the city's deep divides and advocate for our most vulnerable neighbors and disinvested communities.

He previously served as an Advisory Neighborhood Commissioner in Congress Heights where he was raised and still lives, President of the Ward 8 Democrats, National Committeeman for DC's Young Democrats and, as a student, DC's 52nd Youth Mayor.

In 2020, he was a candidate for At-Large member of DC Council to usher in a new generation of DC leadership rooted in community and focused on expanding equity, opportunity and government accountability.

HOW TO VOTE



For the 2022 election season, the DC Board of Elections (DCBOE) is mailing *every registered DC voter* a ballot for the **June 21, 2022 Democratic Primary Election**.

In addition, there will be **40 Vote Centers** open across the District during the early voting period (June 10 - June 19), and **90 Vote Centers** open on Election Day, **Tuesday, June 21, 2022**. Fifty-five dropboxes will be open across the District to drop off your mail-in ballots.

Ward 8 Democrats Platform 2021-2023

1. Statehood for the District of Columbia and all efforts to gain more autonomy over DC government affairs.
2. Greater representation of Ward 8 residents in appointments to the Mayor's cabinet, jobs in the Executive Office of the Mayor, in senior staff positions in DC agencies, and on DC Boards and Commissions.
3. The hiring of more Ward 8 residents to work on District taxpayer-funded projects.
4. Economic development in underserved areas to include opportunity zones, small business incentives and workforce preparedness and education programs. The establishment of worksite child development centers with non-traditional hours.
5. The continuation and strong enforcement of rent control laws and the organizing of more tenants associations.
6. Stronger enforcement of existing environment laws and the promotion of efforts to reduce pollution and conserve natural energy. Deposits on returnable bottles and cans.
7. More public libraries in Ward 8 and public libraries open 12 hours per day, 7 days a week.
8. Sufficient access to healthcare for Ward 8 residents, which include location incentives for primary, ambulatory and ancillary care providers. Great support and meaningful treatment for substance abusers with more available beds.
9. Reduce prescription costs for senior citizens and expanded evening and weekend operating hours for Ward 8 Senior Wellness Center. Increased public and private support for families headed by grandparents.
10. Propose conducting elections by mail and online app.
11. Intensive efforts to establish support and sustain viable PTAs in all Ward 8 schools.
12. Moratorium on liquor stores.
13. Promote quality education for Ward 8 children and schools.
14. Support efforts around community building and crime prevention.
15. Identify partnerships in the community at large to help carry out our mission and goals.
