The Ward Eight Democrats, Incorporated (W8Ds) was founded in 1983. However, the organization was not incorporated until September 11, 1991. The incorporators were Concha Johnson, the late JePhurnmeh Lawrence, the late Newton "Big Newt" Smith and its first president was the late Percy Battle.

The W8Ds is the largest ward organization because all registered Democrats are automatically members and dues are not required.

Any Ward 8 Democrat can attend any general meeting and have immediate right to vote on any issue.

The Ward Eight Democrats meet the third Saturday of each month unless otherwise noted.

We sponsored events on combating opioid overdose and offered support to those experiencing homelessness. We testified before the DC Council for more resources. - Collaborating with constituents to create a platform for issues we need to address



Why Are You Running for This Position: For almost nine terms, I have successfully carried out the responsibility of the Ward Eight Democrats Treasurer in depositing funds, paying obligations, providing monthly reports of financial activities, and filing periodic regulatory reports, in addition to carrying out Executive Committee and Finance Committee responsibilities as required. I want to continue providing this level of consistent service to the organization and membership in satisfying its

mission of voter education and outreach.

Brief Bio: Darryl Ross is the current and nine-term Treasurer of the Ward Eight Democrats. As Treasurer of the organization, he also serves on the Executive Committee and Finance and Fund-Raising Committee. Mr. Ross was a former Second Vice President of the Ward Eight Democrats. Further, he was born and raised in Philadelphia, Pennsylvania; has a bachelor's degree in Accounting from Catholic University; is a Certified Public Accountant; and has been an Auditor in the Federal government for 35 years. Ward Eight Democrats Platform 2019-2021

- Statehood for the District of Columbia and all efforts to gain more autonomy over DC government
 affairs.
- Greater representation of Ward 8 residents in appointments to the Mayor's cabinet, jobs in the Executive Office of the Mayor, in senior staff positions in DC agencies, and on DC Boards and Commissions.
- The hiring of more Ward 8 residents to work on District taxpayer-funded projects.

 and workforce preparedness and education programs. The establishment of worksite child
 development centers with non-traditional hours.

- Sufficient access to healthcare for Ward 8 residents, which include location incentives for primary, ambulatory and ancillary care providers. Great support and meaningful treatment for substance abusers with more available beds.
- Reduce prescription costs for senior citizens and expanded evening and weekend operating hours for Ward 8 Senior Wellness Center. Increased public and private support for families headed by grandparents.
- 10. Propose conducting elections by mail and online app.
- 11. Intensive efforts to establish support and sustain viable PTAs in all Ward 8 schools.
- 12. Moratorium on liquor stores.
- 13. Promote quality education for Ward 8 children and schools.
- 14. Support efforts around community building and crime prevention.
- 15. Identify partnerships in the community at large to help carry out our mission and goals.

Nomination of Officers: All nominations that appear on the official ballot were approved by the Ward 8 Democrats Nomination Committee. The Committee members include:

- Wanda Lockridge, Chairperson and Ward 8 Committeewoman
- Regina Pixley, Ward 8 Committeewoman
- Stephen Slaughter

Candidates had to meet the following criteria:

- Ward 8 resident for at least a year prior to the September 18, 2021 Convention.
- Registered Democrat residing in Ward 8 at least 30 days before the September 18, 2021 Convention.
- Must have attended four (4) Ward 8 Democrats meetings within the past year; attendance was verified via online registration for virtual meetings via the Zoom platform.
- Must have no outstanding or existing financial obligations to the Ward 8 Democrats.
- Individuals who submitted his/her intent to run for a position prior to the September 8, 2021, deadline do not have to be physically present at the Convention to seek election. Non-present members cannot be nominated from the floor.

Nominations from the floor:

Nominations will be accepted from the floor during the Ward 8 Democrats Biennial Convention. Nominated candidates must be physically present and meet the criteria listed above.

Candidate Speeches:

- Candidates for President will be allowed to give a 2-minute candidate statement.
- All other candidates for the other positions will be allowed to deliver a 1-minute candidate statement.
- Questions will not be allowed from the audience.

Voting:

- The voting process will be conducted by members of the DC Democratic State Committee.
- Eligible voters will be determined by the voting rolls housed with the DC Board of Elections.
- Same-day registration is allowable, and the voter will be provided with a
 ballot that will be provisionally sealed until their registration is verified by
 the DC Board of Elections, if necessary.

DEMOCRATS

- Numbered ballots will be provided to State Committee officials by the Nomination Committee at least five (5) working days prior to the election to verify the numbering sequence, the total number of ballots and the imprint with a special mark to prohibit ballot duplication and/or voter fraud.
- Voting will begin at 12:00 p.m. and end promptly at 2:00 p.m. All eligible Ward 8 Democrats in line to vote before 2:00pm will be allowed to cast a ballot.
- Curbside voting shall be made available for any reason, upon request.
- Write-Ins will be allowed but must meet the eligibility criteria stated above.
 The candidate receiving the most votes will be declared the winner.
- Only representatives of the DC Democratic State Committee, excluding WED members, shall publicly count the unchallenged ballots on the premises immediately following the voting. The counters shall reveal the number of challenged ballots.
- Each candidate and/or his/her designee may watch the vote counting.
- If the position is uncontested, declaration of the office may be done by acclamation.
- After verification by the DC Board of Elections, the DC Democratic State Committee, if necessary, shall count all challenged ballots.

Challenged Voter/Ballots Process

- If a voter is not listed on the voter rolls provided by the DC Board of Elections, thereby deemed a challenged voter, the voter must show a voter registration card and photo ID to the registrar.
- Voters may be challenged by only another Ward Eight voter. If the challenge is upheld, his or her ballot is thereby deemed a challenged ballot and the following shall apply:
 - Challenged voter shall be given an index card to record personal data (name, address, voting precinct)
 - Challenged voter shall be given a regular ballot which will be sealed in an envelope for verification by the DC Board of Elections no later than five working days after the election (if required).
 - The challenged ballot envelope shall have the name of the challenged voter and the reason for the challenge displayed on the front.
 - All challenged ballots shall be secured by a designated voter clerk.
